Annual dues are tiered by firm size: \$500 <50 attorneys; \$700 for 50-250 attorneys; \$900 for >250 attorneys. Membership in ILTA is by entity, so that anyone in your organization who has an interest in ILTA's offerings can participate at no additional cost. 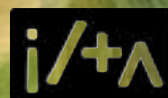
